Future Developments

The ABS would like to announce that it is planning a number of changes to its subscription service.

Commencing in 2002, we will no longer be printing some low demand publications. All titles will still be available electronically through the ABS email delivery service. For subscribers without such facilities, a printed copy can be produced and posted to you. If your subscription is affected you will be contacted in early 2002 to determine your preferred method of delivery.

Secondly, publications that are released less frequently than annually (and some annual releases) are no longer advertised in this catalogue for advance ordering. As there is some uncertainty about the release dates of these publications, the ABS does not want to accept payment in advance. Information regarding publication release dates is regularly updated on the ABS website <www.abs.gov.au> and these products will be available for purchase online, commencing in 2002. See page 21 for further details.

Finally, as there will be a greater emphasis on electronic dissemination of publications in future, the ABS is examining the development of an online subscription service supported by e-commerce facilities. An online subscription service may be implemented in time for the 2003 renewals and you will be notified in due course of the changes and how they affect your subscription.

Of course, the time you receive the publication will depend on the Internet environment outside the ABS including the service provided by your own ISP and your computer environment.

Printed publications are converted into electronic files (pdf format) using Adobe Acrobat software. Most files are about 200–300 Kb in size. Adobe Acrobat is a small, efficient, cross-platform file that is a replica of the paper copy, it appears on screen at the highest possible resolution, and prints on both PostScript and non-PostScript printers. 1370.0 Measuring Australia's Progress

Measuring a nation's progress -- providing information about whether life is getting better -- is one of the most important tasks that a national statistical agency can undertake. And for almost 100 years, the ABS has been measuring Australia's progress through the multitude of statistics we publish relating to the economy, society and the environment. But, for the most part, our statistical publications have tended to focus on each of these three broad areas in isolation from the others.

Recent years have seen growing public interest in the inter-relationships between economic, social and environmental aspects of life. There have, for example, been debates about the sustainability of economic growth and a recognition that the environment is neither an inexhaustible source of raw materials nor capable of absorbing an unlimited amount of waste. Similarly, progress on social concerns -- such as health, education and crime -- has inter-relationships with the growth and composition of economic activity.

Measuring Australia's Progress (MAP) is a new publication that we hope will enhance discussion. MAP considers some of the key aspects of progress side by side and discusses how they are linked with one another. It does not purport to measure every aspect of progress that is important. Nor does it consider all of the many different ways that parts of Australia and groups of Australians are progressing. It does, however, provide a national summary of many of the more significant areas of progress, presenting them in a way which can be quickly understood by all Australians. MAP will, we hope, inform and stimulate public debate and encourage all Australians to assess the bigger picture when contemplating progress in all its forms.

Contains estimates of actual and expected new capital expenditure by type of asset (new buildings and other structures/equipment, plant and machinery) and by selected Australian and New Zealand Standard Industrial Classification subdivisions. These statistics are expressed in current prices and chain volume measures, in original, seasonally adjusted and trend terms.

6202.0 **Labour Force, Australia: Preliminary**

Preliminary results of the monthly Labour Force Survey containing estimates of employed and unemployed persons classified by sex, full-time/part-time status, States and Territories and some age groups; and persons not in the labour force.

5609.0 **Housing Finance for Owner Occupation, Australia**

Presents the number and value of secured finance commitments made by banks, permanent building societies, wholesale lenders n.e.c. and other lenders, provided to individuals/households for the purchase of owner occupied housing. The publication reports lending for the construction of dwellings, the purchase of new and established dwellings, for the refinancing of existing dwellings and for alterations and additions to dwellings.

1307.8 **Australian Capital Territory in Focus**

Presents the latest data on the social, demographic and economic description of the Australian Capital Territory by drawing on a wide range of statistics compiled by the ABS and other organisations. Topics included in the publication range from education, environment, demography, tourism and culture, to government, the economy, foreign trade, law and order, housing and construction, transportation, health and community services, ABS business register counts and the labour market.

1350.0 **Australian Economic Indicators**

Australian Economic Indicators (AEI) is the flagship monthly economic compendium of all the main economic indicators produced by the ABS. It also includes key economic indicators from the Reserve Bank of Australia; Commonwealth Treasury; Australian Bureau of Agricultural and Resource Economics (ABARE); the Australian Stock Exchange and the Organisation for Economic Co-operation and Development (OECD). AEI contains: comprehensive tables and charts on National accounts; International accounts; Consumption and investment; Production; Prices; Labour force and demography; Incomes and labour costs; Financial markets; State comparisons and International Comparisons; feature articles and technical notes relevant to economic analysts; quarterly updates of the Experimental Composite Leading Indicator of the Australian Business Cycle and a quarterly review of the economy. The March through to January issues of AEI generally present the statistics as time series for the last nine years of annual data, and for the last nine quarters or 15 months of sub-annual data. The February issue contains longer time series (20 years of annual, 10 years of quarterly and 4 years of monthly data where available).

3101.0 **Australian Demographic Statistics**

Presents time series data of population estimates, estimates of resident households, births, deaths, infant deaths, marriages, divorces, and interstate and overseas movements. The December 2001 issue will provide preliminary state and territory estimated resident population (ERP) by five-year age groups and sex based on the 2001 Census while the June 2002 issue will provide final data based on the 2001 Census.

3401.0 **Overseas Arrivals and Departures, Australia**

Comprises a summary of monthly data by category of movement. For visitors arriving and residents departing short term, the intended length of stay, main purpose of journey, principal destination (departures) or country of usual residence (arrivals) and State and Territory in which most time was spent.

4102.0 **Australian Social Trends**

Presents statistical analysis and commentary on a wide range of current social issues. Articles are organised into seven chapters, representing the following broad areas of interest: population; families; health; education and training; work; income and housing. Each chapter is supported by a set of summary tables including key social indicators which provide an overview of social change over the past decade, as well as how social conditions differ across Australian States and Territories. A set of international tables also compares Australia with 18 other nations.

The style of the report is clear, focussed and easy to read. Effective use is made of summary tables and graphics to highlight key information. The annual series, as it builds up over time, will provide an invaluable historical perspective of social change in Australia.

4390.0 **Private Hospitals, Australia**

Provides details about the operation of private acute and psychiatric hospitals, and free-standing day hospital facilities in Australia. Information is included about facilities (beds available, special units, etc.), activities (patient throughput, days of hospitalisation provided, bed occupancy rates), patients (types of admitted patients, outpatients and operations performed), staffing and finances.

4611.0 **Environment Expenditure, Local Government, Australia**

This publication focuses on local governments and their role in providing environmental management for their jurisdiction. The publication developed from Environment Protection Expenditure Account, Australia (4603.0) and highlights financial transactions made by local government on environmental issues.

6220.0 Persons Not in the Labour Force, Australia

Persons who were not in the labour force are classified by whether they wanted to work and whether they looked for work in the last 12 months. Data on reasons for not actively looking for work, main activity, time since last job and details of that job are included. Characteristics of persons with marginal attachment to the labour force and discouraged jobseekers are also provided. Estimates can be cross-classified by labour force demographics such as State, sex, marital status and birthplace.

6310.0 Employee Earnings, Benefits and Trade Union Membership, Australia

Contains information from three survey topics: weekly earnings of employees, core employment benefits and trade union members. Weekly earnings data shows the distribution of weekly earnings of all wage and salary earners classified by full-time/part-time status, permanent or casual employee, sector, hours worked and hours paid. Core employment benefits data includes information relating to sick leave, annual leave, long-service leave and superannuation coverage. Information about the level of trade union membership is also provided.

Census of Population and Housing: Selected Social and Housing Characteristics, Australia

Contains 1996 and 2001 Census population counts and selected person, family and dwelling characteristics for all Statistical Divisions (SD) and Statistical Sub-divisions (SSD) within each State and Territory.

Commentary is provided, including a State or Territory summary, regional comparisons for selected topics and time series comparisons. The first release Basic Community Profile (BCP) at Australia level will also be included, along with reference maps. New inclusions for this issue are a set of comparison tables with 1901, 1996 and 2001 data for States, Territories and Capital City SDs; ranked tables for selected characteristics; and person counts on a Usual Residence basis.

2905.0 Statistical Geography: Volume 2 – Census Geographic Areas, Australia

Lists the names, codes and explanatory notes for the geographic areas that are specific to the 2001 Census of Population and Housing, including State and Commonwealth Electoral Divisions, Postal Areas, State Suburbs and Indigenous Geography. Names and codes for the Australian Standard Geographical Classification areas are not listed.

2001 CENSUS

The 2001 Census of Population and Housing was held on 7 August 2001. Since 1961 a census has been taken in Australia every five years. The objective of the census is to count the number of people in Australia on census night, identifying their key characteristics and those of the dwellings in which they live.

Information contained in most census products is based on 'place of enumeration' - that is, where people were counted on census night. Census counts are also available on a 'usual residence basis' – that is, where people normally reside.

Two stage release

A two stage release strategy is in place for 2001 census data. The first release of data is planned for July 2002 and the second release is planned to commence in late 2002. This strategy places priority on the early dissemination of data which is easily processed. Census products based on first release data available in 2002 include:

- Social and Housing Characteristics publications;
- · Social Atlases;
- Basic Community and Indigenous Profiles;
- Census Snapshots

Also to be released in 2002 are the CD-ROM products:

- CDATA2001 (Release 1);
- CLib2001 (Release 1);
- The Census Guide.

Census Data on the ABS Website

A number of census products will be available free of charge via the internet. These products include:

- *Basic Community Profiles* for geographic areas down to Statistical Local Area;
- Main findings from *Selected Social and Housing Characteristics* (Cat. no. 2015.0 .8) publications;
- · Census snapshots.

Selected Social and Housing Characteristics, Australia (Cat. no. 2015.0) is the first release of census data. It contains 2001 census population counts and selected person and dwelling characteristics for all Statistical Divisions and Statistical Sub-divisions within each State & Territory. It also includes 1996 counts at Statistical Division level for comparison.

This 2001 Census publication has several innovations including:

- a summary table comparing data from 1901, 1996 and 2001 for Australia, States & Territories;
- a summary table comparing data from 1996 and 2001 for Capital City Statistical Divisions;
- data on households which used a personal computer or the internet;
- ranked tables for selected characteristics;
- person counts on a Usual Residence basis;
- a table showing basic family information.

Another feature included in this publication is the first release Basic Community Profile for Australia, a series of 21 informative tables.

The State and Territory level publications, *Selected Social and Housing Characteristics for SLA's* (Cat. no. 2015.1 – 8) are based on the Australia publication in format and content but have data at Statistical Local Area (SLA) level.

Social Atlases present thematic maps of the key social, demographic and economic characteristics of each capital city in Australia. A brief commentary explaining the main features and characteristics accompanies each map. A common core set of maps are included in each *Social Atlas* for population, ethnicity, education, families, income, labour force and dwellings. Each *Social Atlas* includes maps that highlight unique attributes pertaining to that particular capital city. *Social Atlases* will be released progressively from November 2002 to April 2003.

Publications

Selected Social and Housing Characteristics

These publications provide users with easy access to a range of basic 2001 census information. There are seperate publications for Australia and for each State and Territory.

Community Profile Series

Community Profiles are a set of standard tables which contain key social, demographic and economic characteristics of people, families and dwellings. They are an economical way of obtaining a statistical picture of a community and making comparisons between different areas or different population groups.

The 2001 Census Community Profile Series will be available in hardcopy or electronically, with all tables accessible via the internet, many free of charge. Electronic versions of the Community Profiles will be provided with free windows-based manipulation software which allows users to view and manipulate data. The community profiles will be available in formats suitable for use with a range of spreadsheets, applications and databases.

Two Community Profiles will become available in 2002:

The *Basic Community Profile* (BCP – Cat. no 2001.0) contains 33 tables of detailed data for all Australian Standard Geographical areas of CD-derived postal areas, suburbs and Commonwealth and State Electoral Divisions. The BCP will be issued in 2 releases: tables 1-21 containing the first release variables; and tables 22-33 containing second release variables.

The *Indigenous Profile* (Cat. no. 2002.0) contains 29 tables for all ASGC areas from SLA level to whole of Australia, as well as Indigenous areas and Aboriginal and Torres Strait Islander Commission (ATSIC) regions. Tables 1 – 11 are included in the first release, with tables 12 – 29 included in the second release.

Census Snapshots

Census Snapshots are designed to provide a brief summary of 2001 census data for selected areas and are available free of charge from the ABS website.

Snapshots contain subsets of community profile data including person counts, age and birthplace presented in a narrative form for easy access by a wide audience. For comparison some 1901 data will also be available for Australia and States and Territories.

CD-ROM Products

CDATA2001 Release 1

CDATA 2001 products contain a large volume of tabulated census data, digital boundaries and base map data with software to produce tables, maps and graphs of the data. The product is available at national and State/Territory levels. CDATA2001 Release 1 will contain first release data only. There are 2 CDATA products::

CDATA2001 – *Full GIS*: Will use MapInfo Professional Geographic Information System (GIS) as the mapping engine which allows users to conduct detailed analysis using Structured Query Language (SQL), allowing the export of statistical data for use in other applications, and the import of other data in a variety of formats.

CDATA2001 – *Quickbuild*: New for the 2001 census, this version contains reduced GIS software functionality when compared to that available in CDATA2001 – *Full GIS*, but with complete access to all statistical and boundary data. The more complex GIS facilities such as Structured Query Language, importing of external data, geocoding and point creation are not available. CDATA2001 – *Quickbuild* users will have the facility to upgrade to CDATA2001 – *Full GIS* if desired.

CLib2001 (Release 1)

CLib 2001 is provided free of charge to libraries participating in the ABS Library Extension Program as a community service. CLib2001 contains a large volume of tabulated data and software that allows access, display and printing. The 2001 Census edition of CLib will be available both as a CD-ROM and a (limited access) internet based product.CLib2001 will contain a simplified and intuitive interface including the provision of flexible topic and area search facilities, supporting conceptual information and a streamlined printing facility. Area selections for this product will also be made easier via an intuitive, drill down map interface incorporating key geographical identifiers. The data content will be similar to that of CLib96, comprising the complete 2001 Census Community Profile Series and Classification Counts. Release 1 of CLib2001 will include first release data only.

The Census Guide

The Census Guide is the complete source of reference information about the census, and is free of charge. It provides a range of information about the census including the census dictionary as well as product and service information.

5204.0 Australian System of National Accounts

This publication contains detailed presentation of annual national accounts data. It includes: main aggregates and productivity measures; sectoral accounts for households, financial and non-financial corporations, general government and the rest of the world; estimates of product, operating surplus, compensation of employees and other aggregates dissected by industry; tables of capital formation and capital stock; national balance sheets; flow of funds tables. Includes both current price and chain volume measures.

5250.0 Australian Business Expectations

Contains estimates of percentage change in key business performance indicators obtained from a sample survey of business in all industries except general government and agriculture, forestry and fishing. Expected aggregate percentage change and percentage weighted net balance (percentage of businesses expecting an increase minus the percentage of businesses expecting a decrease) is provided with respect to the next quarter (compared with the current quarter), and the current quarter of the following year (compared with the current quarter). This information may be classified by: commodity; country and/or Australian state of origin or destination. Trade through overseas ports may also be reported if required, as may information on various modes of transport. Rate of duty and duty paid are also available for import clearances only.

Frequency and Timeliness

International trade statistics are compiled each month and may be received on monthly, quarterly, six monthly or annual basis. Import and export clearance statistics are available 12 working days, and exports 21 working days after the end of the month to which they refer.

5512.0 Government Finance Statistics, Australia

Government Finance Statistics (GFS) are compiled for the general government and the consolidated non-financial public sector for each jurisdiction in accordance with international statistical standards. The publication contains operating statements featuring the GFS Net Operating Balance and GFS Net Lending/Borrowing measures, balance sheets showing the GFS Net Worth and cash flow statements with supplementary data on the Surplus/Deficit measure. What are the Producer Price Indexes?

The Producer Price Indexes (PPIs) are measures of changes in producers' prices, similar to the better known Consumer Price Index (CPI). While the CPI measures change in retail prices paid by households for goods and services, the PPIs measure changes in the prices of goods and services sold to businesses. Producer Price Indexes are compiled for the following sectors of the economy:

- building and construction price indexes are produced which measure changes in the prices of materials in constructing: (a) houses; and
 (b) other buildings (e.g. office blocks; shopping centres, schools, hospitals etc.);
- manufacturing industry price indexes are compiled measuring changes in: (a) prices paid by manufacturer for materials used in producing manufactured goods; and (b) prices received by manufacturers for articles they produce;
- service industries price indexes are produced which measure changes in the prices received by the suppliers of selected services and
- international trade price indexes are compiled measuring changes in the prices of merchandise exports and imports.

Price indexes are also produced for the supply of commodities to the Australian economy in a 'stage of production' framework.

6401.0 Consumer Price Index, Australia

Presents movements in retail prices of goods and services commonly purchased by metropolitan households. The goods and services are divided into the following groups: food; alcohol and tobacco; clothing and footwear; housing; household furnishings, supplies and services; health; transportation; communication; recreation; education; and miscellaneous. Indexes for each of these groups and for 'All Groups' are published for each of the State capitals along with Canberra and Darwin, and for the weighted average of the eight capital cities. Details are also shown for about 54 sub-groups and special and analytical series, for the weighted average of the eight capital cities.

6457.0 International Trade Price Indexes, Australia

Contains indexes measuring changes in the prices of imports of merchandise that are landed in Australia each quarter (the Import Price Index), and exports of merchandise that are shipped from Australia each quarter (the Export Price Index).

A statistical compendium of Australia's wine and grape industry containing information on: area of vines and production of grapes by region; wine production and grapes crushed by region; structure of the wine manufacturing industry; inventories of wine owned by winemakers at 30 June; brandy and grape spirit production; domestic wine sales; exports and imports of wine; price indexes of grapes and wine; consumption of wine; and world wide comparisons.

7121.0 Agricultural Commodities, Australia

Presents final estimates for the main commodities collected in the Agricultural Census. These include broadacre crops, fruit and nuts, vegetables and livestock. Also includes details of industry structure including counts of farms by the Australian and New Zealand Standard Industrial Classification and size (physical and economic).

7215.0 Livestock Products, Australia

Provides quarterly statistics on livestock slaughterings (including chickens), meat production, milk intake by factories, market milk sales by factories, receivals of wool by brokers and dealers, exports of live sheep and cattle, exports of meat and stocks of frozen meat. Includes seasonally adjusted and trend totals for numbers slaughtered, meat produced, whole milk intake and wool receivals.

8504.0 **Sales of Australian Wine and Brandy by Winemakers**

Presents information on the quantity of Australian produced wine (classified by type — fortified, table, sparkling, etc.) and brandy sales. Sales of table wine are classified by container type for both white and red/rosé table wine. Sales of fortified wine are further classified by container type, with glass containers less than 2 litres split into sherry, port and other. Includes seasonally adjusted and trend series for total domestic wine sales; total white and red/ros table wine; bottled white and red/ros table wine; and soft pack white and red/ros table wine. Also includes wine and brandy exports and imports cleared for home consumption.

8634.0 **Tourism Indicators, Australia**

Contains previously unpublished and derived data from the Survey of Tourist Accommodation (STA) and Overseas Arrivals and Departures (OAD) collections. For the STA collection, seasonal and trend data and takings data at constant prices as well as previously unpublished operating ratios are presented. From the OAD collection, previously unpublished market-segmentation data are included. Analytical articles relating to both collections are also included. Will include regular articles relating to other ABS tourism-related collections and a section of brief articles relating to statistics and developments in the tourism field.

8752.0 Building Activity, Australia

State data includes the number of private sector houses approved, and for Capital City Statistical Divisions, the total number of dwelling units approved by sector. Seasonally adjusted and trend estimates by state are included for the number of dwelling units and value of building approval is shown in chain volume measure.

9312.0.30.001 Motor Vehicles on GSP

A CD-ROM product providing a complete picture of the motor vehicle fleet from the Motor Vehicle Census based on the latest GSP (Geographic Statistics Platform) software developed for the Integrated Regional Database.

This 'stand alone' package contains data for 1997, 1998 and 1999 and includes details such as type of vehicle, make, model and year of manufacture.

Data is available by postcode, Statistical Division (SD), Statistical Sub-Division (SSD) and Statistical Local Area (SLA). Mapping is available and clients can develop their own set of regions using groupings of geographical areas.

GSP software allows the user to combine data from a variety of collections and produce their own data items. For example, population data can be combined with motor vehicle census data to produce counts of the number of Ford or Holden passenger vehicles per head of population across all SLAs or for specific sets. Note that the associated standard IRDB GSP package includes some summary data from the Motor Vehicle Census along with the full integrated regional data from both ABS and non-ABS sources. Clients who purchase IRDB on GSP can also purchase the Motor Vehicle data as an add-on to the IRDB data.

1353.0 Integrated Regional Database (IRDB) Australia

The *IRDB* provides a wide range of social, economic, and environmental data on both a regional and time series basis. The Database contains information from social and economic collections of the ABS and other Commonwealth Agencies, with data generally available from 1986 (and earlier for some items). Statistics are available on the environment, health and disability, employment and unemployment, rural economies and electoral matters. All data are available from Statistical Local Area (SLA) to Australia level, with interactive tables, graphs, maps and reports generated from screen based selections of areas, data items and time periods.

In addition to powerful exporting and importing capability and extensive metadata, *IRDB* has unique functions to handle geographic boundary changes, allowing a wide range of data items to be compared on a consistent regional basis over time. The optional mapping module allows users to further examine the data through a powerful, integrated Geographical Information System.

5302.0.15.001 Balance of Payments and International Investment Position, Australia – Time series

Provides quarterly long term detailed balance of payments tables on current, capital and financial transactions, including seasonally adjusted, trend and chain volume measures of the current account. It also provides a complete international investment position statement with details of the level of investment, investment flows and associated income. Information is also provided on Australia's foreign debt, exchange rates and analytical ratios.

5338.0 Balance of Payments, Australia – Regional Series

Provides country and regional estimates of Australia's current and capital accounts. The current account includes credit and debit estimates for goods, services, income and current transfers. Services are further broken down into: transportation; travel; communication; construction; insurance; financial; computer and information services; royalties and license fees; other business services; personal, cultural and recreational services; government services; and other. Income is further broken down into compensation of employees and investment income.

5361.0.40.001 Balance of Payments, Australia: Quarterly Forward Seasonal Factors

Provides forward seasonal factors for balance of payments series, for each quarter of the current year, for the components of: goods credits and debits; services credits debits; and income credits and debits; and for the aggregates of current transfers credits and debits. Factors are resupplied during the year if reanalysis are required.
