

INTRODUCTION

THE CENSUS

The Census of Population and Housing is the largest statistical collection undertaken by the Australian Bureau of Statistics. The key objectives of the census are to measure the number and key characteristics of all people in Australia, and the dwelling in which they live, on census night.

The wealth of information collected through the Census is a valuable asset for Australian society.

Census information is used to support the planning, administration. policy development and evaluation activities of governments, business. researchers and many other users.

Census information can be obtained either as standard products and services, or as customised services, tailored to your needs.


THIS DIRECTORY

This Directory is a reference to the current products and services developed from the information collected from the last Census, held on 6 August 1991. It will help you to find census information for your particular needs.

SNAPSHOT OF AUSTRALIA

When deciding between census products and services you are reminded that the information contained in most census products is based on the "place of enumeration". This means it is based on where people were actually staying on census night, 6 August 1991. People were also asked where they usually lived,

and this information is coded to Statistical Local Area, resulting in "usual residence" based information. See the glossary of terms included in this Directory for an explanation of these terms. or ask the ABS Consultants for advice.



ABS LIBRARY EXTENSION PROGRAM

The Australian Bureau of Statistics is committed to providing access to census - and other ABS information - to all members of society, through the Australian library network. A collection of standard census publications are held by participating libraries.

In addition, the ABS has developed a CD-ROM product, CLIB91, to provide people with electronic access to census information through selected libraries.

Your nearest Public, University, TAFE or State Libarary is likely to be one of the 560 members of the Library Extension Program. Contact the Reference Desk at your local library and ask if they are a member of the ABS Library Extension Program.

NEXT CENSUS

Planning is now under way for the next Census of Population and Housing which will be held on 6 August, 1996. Information from the 1996 Census will be released progressively after mid 1997.


POPULATION GROWTH AND DIS1

This report analyses the family structure, demography, housing, education, income and labour force experience of Aboriginal and Torres Strait Islander people.

The report includes the Aboriginal and Torres Strait Islander Community Profile for Australia - 29 tables based on key census characteristics of Aboriginal and Torres Strait Islander people, families and dwellings.

CENSUS CHARACTERISTICS OF (STATE/AUSTRALIA)



The Census Characteristics series presents census counts of people and dwellings, cross-classified by social and demographic characteristics.

Topics covered in one or two page tables include: age, language, birthplace, religion, education, income, labour force, usual residence, family, dwelling and household.

There are nine separate publications, one for each State and Territory and one for Australia.

CENSUS COUNTS FOR SMALL AREAS



The Census Counts for Small Areas series contains final population and dwelling counts from the 1991 Census for each State and Territory. You can determine how many people were counted in different areas of each State and Territory. To see the changes in the population, the results of the 1986 Census have been included where areas are comparable.



The publication contains counts of persons (analysed by age and sex). dwellings (analysed by whether a private dwelling, or non-private dwelling e.g. motels). These counts are provided for Statistical Divisions, Statistical Subdivisions, Legal Local Government Areas. Statistical Local Areas, and urban centres/localities.

A separate publication is available for each State and Territory.

ABORIGINAL PEOPLE IN SOUTH AUSTRALIA

Included is commentary on demography, family structure, housing, education, income and labour force experience for Aboriginal and Torres Strait Islander people in South Australia. Comparisons are made between different areas within the State, and with South Australia's non-indigenous population.

Each Community Profile includes a set of tables containing key census characteristics of persons, families and dwellings - which in fact cover most of the topics on the census form.

Just choose your geographic area of interest and preferred profile to get access to simple to use, inexpensive and comprehensive census information.

BASIC COMMUNITY PROFILE

This profile contains 58 tables for all census geographic areas ranging from Census Collection Districts to total Australia, including Collection District Derived Postcodes. It is based on the place of enumeration i.e. where people were counted on census night.

You will find tables on these topics: Aboriginal and Torres Strait Islander people, age, birthplace, citizenship, dwelling, education, ethnicity, family, household, housing costs, income, industry, internal migration, journey to work, labour force, language, marital status, motor vehicles, nature of occupancy, non private dwelling, occupation, offspring, qualifications, religion, structure of dwelling, usual residence, year of arrival, and more.

EXPANDED COMMUNITY PROFILE



This profile is comprised of more detailed versions of most of the Basic Community Profile tables plus some new tables. The Expanded Community Profile contains 45 tables and is available for Statistical Local Areas and most other census geographic areas. Collection Districts, Collection Districts Derived Postcodes, and Localities are not included. This profile is based on the place of enumeration.

Free templates of each Community Profile are available on request. These templates are spreadsheets containing table titles, row and column labels and cell references.





TIME SERIES COMMUNITY PROFILE



This series takes 22 tables from the Basic and Expanded Community Profiles and compares data from the 1981, 1986 and 1991 Censuses where the classifications are comparable.

Topics you will find in the *Time* Series Community Profile include: Aboriginal and Torres Strait Islander people, age, birthplace, citizenship, dwelling, education, ethnicity, family, industry, labour force, language, marital status, nature of occupancy, non private dwelling, occupation and religion.

This profile is available for Statistical Local Areas, and aggregates of Statistical Local Areas. This profile is based on the place of enumeration.

ABORIGINAL AND TORRES STRAIT ISLANDER PEOPLE COMMUNITY PROFILE

This profile contains 29 tables on Aboriginal and Torres Strait Islander people.

EXTERNAL TERRITORIES COMMUNITY PROFILE

This profile contains 53 tables. Topics included are similar to those from the *Basic Community Profile*. This profile is based on the place of enumeration.

WORKING POPULATION PROFILE

This profile contains labour force and related data on the characteristics of people who work in Statistical Local Areas within the journey to work study areas. This profile is based on the place of enumeration.

Topics covered in 17 tables include age, education, ethnicity, income, industry, journey to work, labour force, language, marital status, and occupation.

The journey to work study areas are: Sydney/Wollongong/Newcastle, Melbourne/Geelong/Latrobe Valley/ Bendigo/Ballarat, Brisbane/Gold Coast/ Sunshine Coast, Adelaide, Perth, Hobart/ Launceston, Darwin, and Canberra/ Queanbeyan.

USUAL RESIDENTS COMMUNITY PROFILE

This profile contains 25 tables and is based on the place of usual residence.

Topics include: Aboriginal/Torres Strait Islander people, age, birthplace, citizenship, education, ethnicity, income, industry, internal migration, labour force, language, marital status, non-private dwelling, occupation, and year of arrival.

This profile is available for Statistical Local Areas (SLAs), aggregates of Statistical Local Area (SLAs), and 1991 Census modified Australia Post postcodes.



CTAB91 contains the entire Standard Matrix and Comparison Series on CD-ROM. CTAB91 contains the National Standard Matrixes, State Standard Matrixes, Aboriginal and Torres Strait Islander Standard Matrixes, as well as the State Comparison Series, Capital City Comparison Series and the Statistical Region Comparison Series.

These counts and tables are easy to use - you can quickly access and display what you need, or further aggregate categories into the categories you are interested in and then print the results. You can also export the information into other software packages.

CT 1B91 has many applications. For example, an ethnicity study by a city council requiring birthplace and marital status data for every Statistical Local Irea in the Sydney Statistical Division would easily find the information they want from a State Standard Matrix. Or a study about people attending different types of educational institutions would use the National Standard Matrix "CBC5016". This matrix identifies the birthplace, age, sex and labour force status (full-time or part-time work) of the people who are attending different types of education institutions.

Socio-Economic Indexes For Areas are lifestyle groupings of Australia's communities. There are five indexes which group Australians according to their social and economic conditions.

The five indexes are:

- Urban index of Advantage
- Rural index of Advantage
- Index of Disadvantage
- Index of Economic Resources
- Index of Education and Occupation

These indexes reveal where the affluent (as opposed to just high income earning) live; where the disadvantaged (as opposed to the unemployed) live; where the highly skilled and educated (as opposed to the degree-holding people) live.

Socio-Economic Indexes for Areas provides information and rankings for a wide range of geographic areas from small areas such as a collection district (of a few suburban streets), postcodes. Local Government Areas, and Statistical Local Areas, to large areas such as Statistical Sub-Divisions. Alternatively, you can tailor areas to your own specifications.

Socio-Economic Indexes for Areas is available as a stand alone product or as an add-on for use with CDATA91 with MapInfo software functions. Either way you can export the indexes to spreadsheets and other packages.

The indexes are useful for targeting areas for businesses and services

such as siting retail outlets and for determining allocation of resources. They are also useful for research studies requiring summary information on socio-economic factors.

A sample file of unidentified households with associated persons has been produced for

specialised research and manipulation of census data.

The 1991 Census Household Sample File is excellent material for model testing or for statistical analysis. It is a one percent sample of private households and associated persons plus a one percent sample of persons in non private dwellings.

Records on the 1991 Census Household Sample File include:

- Dwelling records
- Family records
- Person records

The records that make up this sample file have been taken from collection districts in each State and Territory. The records contain only very broad geographic identifiers.



CENSUS REFERENCE MAP PRODUCTS

A range of mapping products are available to help you to identify different census geographic areas, to map your own information onto selected census geographic areas. Note that these maps show census boundaries only, not data. See the Consultancy Services Section for customised mapping services.

These reference maps show Collection District (CD) boundaries and codes printed in red on a detailed topographic base printed in black (containing street patterns) for the whole of Australia.

Collection District boundaries are the basic building blocks for the census. Legal Local Government Areas, Statistical Local Areas. Statistical Sub-divisions and Statistical Divisions are all derived from CDs, as are most user-defined areas for which census data is required.

All maps come with indexes of codes and names for geographic areas and a pictorial index showing the area covered by map sheets in each Statistical Division.

The hardcopy maps are sold in volumes of approximately 150 maps, with each volume containing one or more Census Divisions on a State/Territory basis. There are 66 volumes in total. Maps are also available on microfiche, in black and white only.

Stocks are limited and will not be reproduced once sold out.

DIGITISED CENSUS BOUNDARIES

If you use desktop mapping or GIS software for your work, add a geographic dimension to your data by using the *Digitised Census Boundaries*. All census boundaries from the smallest areas such as Collection Districts or Statistical Local Areas, to large areas such as States, Territories or Australia are available electronically. Digitised Boundaries are compatible with any computer mapping software.

If you are involved in policy development, planning, marketing, or any geographically based analysis, *Digitised Census Boundaries* are an essential tool.

Choose the level of accuracy you need.

All Collection District boundaries for the 1991 Census are digitised i.e. the image is graphically traced and points on that image are converted into co-ordinates of latitudes and longitudes. These co-ordinates or points are then stored in electronic files. These files are available in three levels of filtering:

- Shapes
- Standard
- All points





The 1991 Census Geographic Areas lists names and codes of standard geographic areas used in the 1991 Census, including Australian Standard Geographical Classification (ASGC) areas, and Commonwealth and State Electoral Divisions/Districts.

The codes enable you to cross reference geographic areas in this publication with areas in other census products which use codes only, such as maps.

If you need to determine the location of a geographical area in which you are interested, in relation to the classification bierarchy, then the 1991 Census Geographic Areas is essential.

For example you can find the Statistical Division in which a Statistical Local Area is located in or you can find out whether a particular Legal Local Government Area consists of more than one Statistical Local Area.

This is a list of codes and names of urban centres and localities for the 1991 Census as defined by the Australian Standard Geographical Classification.

GLOSSARY OF COMMON CENSUS TERMS



The geographic areas used for the collection and dissemination of census data are divided into two types: Australian Standard Geographical Classification (ASGC) areas and standard non-ASGC areas. User defined areas can be created by aggregating Collection Districts. See 1991 Census Geographic areas in this Directory. For more information see the 1991 Census Geographic Areas.

Australia Post Postcodes (1991 Census Modified)

These are official areas as defined by Australia Post and digitised by the Australian Surveying and Land Information Group (AUSLIG) then modified to fit the digitised base of Peripheral Systems Pty Ltd. (see Digitised Boundaries). These boundaries are not based on Collection Districts so they will not match up with Collection District boundaries. See also CD Derived Postcodes.

Census Division

Census divisions are administrative units designed for the distribution and collection of census forms.

Census Subdivision

For administrative purposes, census divisions are divided into census subdivisions. Census subdivisions are designed to group together about 10 to 12 collection districts.

Collection District (CD)

The Collection District has been designed for use in the Census of Population and Housing as the smallest unit for collection, processing and output of data. Collection Districts also serve as the basic building block in the ASGC and are used for the aggregation of statistics to larger ASGC areas and some non-ASGC areas such as Commonwealth and State electoral divisions.

Collection District Derived Postcodes

Collection District Derived Postcodes are approximated by aggregating Collection Districts that lie wholly or partly within a postcode area. A new boundary is then drawn to encompass all the Collection Districts and the data for the Collection Districts are aggregated. See also Australia Post Postcodes.

Confidentiality

Under the Census and Statistics Act 1905,

it is an offence to release any information collected under the Act that would enable identification of any particular individual or organisation. During every stage of the census, strict measures are taken to ensure confidentiality.

Electoral Division

Electoral divisions are not standard census geographic areas. They are approximated by aggregating the data for collection districts that lie wholly or partly within the electoral district.

Enumeration

Enumeration is the act of counting or summing. The census is conducted by self-enumeration. Census counts are provided on two bases of enumeration - by place of enumeration (where they are on census night) and by place of usual residence (where they usually live).

Estimated Resident Population (ERP)

Estimated Resident Population (ERP) is the official ABS estimate of the Australian population. The ERP is based on the results of the population census and is compiled for each census and updated annually between censuses.

Geographic Areas

The geographic areas used for the collection and dissemination of census data are divided into two types: Australian Standard Geographical Classification (ASGC) and other standard non-ASGC areas. Census data is collected for small areas called Collection Districts. This Collection District base allows the aggregation of data into larger areas, for example, Statistical Local Areas (SLAs) and Local Government Areas (LGAs).

Legal Local Government Area (LLGA)

The legal local government area is a geographic area under the responsibility of an incorporated local government council. There are 832 legal LGAs in Australia which collectively cover only a part of Australia. The major areas not covered by legal LGAs are the large northern parts of South Australia, almost all of the Northern Territory and all of the Australian Capital Territory.

Place of Usual Residence

Not all people are at home on census night: they may be in a motel or at a friend's place. Question 7 on the census form asks for the address of each person's place of usual residence. This allows statistics to be compiled based on people's place of usual residence. Place of usual residence counts can be provided for SLAs, any aggregations of SLAs and postcodes.

Statistical Local Area (SLA)

Statistical Local Areas consist of one or more Collection Districts. They can be based on legal local government areas, or parts thereof, or any unincorporated area.

Statistical District

Statistical Districts consist or one or more statistical subdivisions and represents a large urban area of Australia outside state capital city statistical divisions.

Statistical Region

Statistical Regions consist of one of more statistical local areas and cover, in aggregate, the whole of Australia without gaps or overlaps.

Statistical Division

Statistical Divisions consist of one or more statistical subdivisions and cover, in aggregate, the whole of Australia without gaps or overlaps. They do not cross State or Territory boundaries and are the largest statistical area building blocks of States and Territories.

Statistical Subdivision

Statistical Subdivisions consist of one or more statistical local areas and cover, in aggregate, the whole of Australia without gaps or overlaps.

Undercounting

All census counts refer only to people whom census collectors have been able to enumerate on census night. However, a very small number of people and dwellings would have been missed and some might have been counted more than once. The term attached to this is undercounting or under-enumeration.

Urban Centre/Locality

An urban centre consists of one or more adjoining whole Collection Districts with urban characteristics and representing a population cluster of 1,000 or more people. A locality is a population cluster of between 200 to 999 people.

For more information, refer to the 1991 Census Dictionary, and the Australian Standard Geographical Classification Manual or the 1991 Census Geographic Areas.
