10. Secondary distribution

There are two price structures associated with ABS products: one for 'secondary distributors' of ABS data, the second for other users.

The term secondary distributor applies to any person or organisation obtaining ABS data and then distributing products to a third party where a major component of the products consists of ABS material.

Under the Conditions of Sale, secondary distribution of ABS data cannot occur without prior written consent and payment to the ABS of appropriate charges.

Negotiations will be undertaken individually with secondary distributors to determine appropriate financial arrangements. Two basic financial arrangements (or a combination of both) may be negotiated with secondary distributors:

- a licence fee, either on a one-off basis or to be renewed regularly, or
- payment of royalties on a prescribed basis (e.g. a set percentage of sales revenue).

Secondary distributors should contact Information Services to negotiate financial arrangements. Addresses and contact numbers are shown in Appendix A.

Persons or organisations preparing consultancy or research reports that rely on ABS data are not regarded as secondary distributors, provided that research and analysis is the major component of the reports.

11. Standard output on magnetic tape

12. CDATA86 - Small area data on CD-ROM (compact disk): 1981 and 1986 Censuses

CDATA86 consists of CD summary data for both censuses and digital boundary data, with aggregation, tabulation and mapping software. Using Supermap Version 3.11, CDATA86 operates in a DOS or windows environment. The price of this product is \$5,500. CDATA86 users who wish to update their Supermap software may purchase Supermap Version 3.11 for \$1,500. A discount price of \$1,000 applies to primary and secondary educational institutions. In addition, discounts apply to bulk purchases.

Secondary distributors are not charged a licence fee for this product.

13. Small area data on floppy disk (2195.0)

Prices vary depending on the number of disks required to contain the data and whether the disks contain standard or customised data. The disk containing the decompression/selection/aggregation program is provided free of charge.

Prices for secondary distributors are higher than those listed below (see section 10 for definition and type of financial arrangements). Negotiations on financial arrangements will be undertaken individually with secondary distributors.

For customised collection district (CD) data the charges are:

- (a) \$110.00 basic charge.
- (b) 50c plus 7c per page for the data for each CD (\$1.00 if all pages required).

A discount may be offered for the bulk purchase of CD data:

- from 1-100 CDs — no discount
- from 101-1000 CDs — 50% of (b)
- more than 1000 CDs — 75% of (b)

Spreadsheet 'templates' are \$60 each.

14. Cross-classified tables on floppy disk (2195.0)

There is a basic charge of \$50 per order to cover the cost of product development which must be added to the price. The selection/decompression/reformatting program is provided free of charge. Note that no spreadsheet templates are available for these files. Cross-classified tables on floppy disk are the same as those tables on magnetic tape; see Section 11 for a list of table numbers and prices.

15. Census Consultancy Service

Data available from the census consultancy service falls into three categories:

- customised cross-classified tables
- tabulations and choropleth maps from CDATE86 or the small area data base
- other services (such as tabulations requiring special computer programs)

There are various computing and clerical costs associated with census consultancy requests. The cost of each request will vary according to the degree of complexity, and the amount of computer time that is required to process the request.

To obtain a firm quotation for the particular service required, please contact the nearest ABS Office (see Appendix A for addresses and telephone numbers).

Secondary distributors will be charged, in addition to the calculated cost, a fee to cover a licence or royalty payment for the commercial use of the data (see Section 10).
