



**DESCRIPTION** 

The survey results form the first large-scale national profile of Australians' literacy skills, that is, those skills required to use printed material found at work, at home and in the community. There were two components to the survey. The first component was an interview in which background socio-demographic information was collected and grouped into the following main areas: health, education, labour force participation, income, language, literacy activities performed at home and at work, and parents' education and occupation. The second component was an objective assessment of some literacy skills using examples of commonplace tasks of varying difficulty. These tasks assess three different types of literacy: prose literacy — the ability to understand and use information from various kinds of prose texts, including texts from newspapers, magazines and brochures; document literacy — the ability to locate and use information contained in materials such as tables, schedules, charts, graphs and maps; and quantitative literacy — the ability to perform arithmetic operations using numbers contained in printed texts or documents.

Scope

The survey covered all persons aged 15–74 years who were usual residents of private dwellings, excluding overseas residents in Australia; certain diplomatic personnel of overseas governments; and members of non-Australian defence forces (and their dependants) stationed in Australia. The survey was conducted in both urban and rural areas in all States and Territories, but excluded persons living in certain remote and sparsely settled parts of Australia.

# METHOD OF COLLECTION

Background information was collected from a randomly selected member of each selected household by specially trained ABS interviewers. Respondents were then asked to complete a set of literacy-related tasks. The objective assessment of literacy skills was based on a methodology developed by the United States' Educational Testing Service and Statistics Canada which has been adapted for use in several countries.

Note: This survey is part of the International Adult Literacy Survey being coordinated by Statistics Canada, which involves many countries conducting similar surveys.

DESCRIPTION

The Commercial Training Providers Survey was designed to investigate private sector organisations conducting vocational training on a fee-for-service (commercial) basis. The aim of the survey was to measure the contribution that private training providers make to vocational training in Australia.

Scope

The survey was conducted in 1994 and included organisations that conducted training on a commercial basis, during the 12 month period of 1994. Included in the survey were: organisations operating primarily as providers of training on a commercial basis; professional and industry associations which provide training on a commercial basis; employers offering training to employees of other organisations on a fee-for-service basis but whose training effort is primarily directed at their own employees; and equipment manufacturers and suppliers who provide training on a commercial basis.

All government-sponsored training and education institutions, schools, and colleges were excluded from the survey. The survey covered commercial training providers in all States and Territories.

# METHOD OF COLLECTION

The sample was selected from a national register of commercial training providers developed by the ABS specifically for the conduct of the survey. The survey was conducted in two phases. First, an initial approach was made to organisations who received an 'Initial Contact Form' designed to identify the type of training organisation they were and the appropriate contact person. Approximately 1,000 commercial training providers were selected. Collection of the data then followed.

DESCRIPTION

The 1997 Survey of Education and Training follows on from similar surveys conducted in 1993 and 1989 but with an increased emphasis on the education component. The survey provides information on education and training outcomes, with a focus on pathways of education and training, and on access to education and training in Australia.

Scope

The scope of the survey includes all persons aged 15–64 who had worked as wage or salary earners in the previous 12 months, or those who, at the time of the survey, were employees, employers, self-employed or marginally attached to the labour force. Information was also sought from persons studying either part-time or full-time, including those aged 15–20 years still at secondary school. Excluded were persons who were permanently unable to work, boarding school pupils not resident in households, some patients in hospitals and sanatoriums, and inmates of gaols, reformatories, etc.

# METHOD OF COLLECTION

Households were selected at random, Australia wide. Approximately 16,000 dwellings were included. Responses were obtained by personal interview.

# HISTORICAL DATA

Comparisons are possible with the 1993 survey and the 1989 How Workers Get Their Training Survey. However, the scope of the 1989 survey was restricted to those who had been wage or salary earners in the previous 12 months, while the subsequent surveys are more inclusive. Care must therefore be taken when comparing the results between surveys.

DESCRIPTION

This survey was designed to collect information on the destination of 1994 TAFE graduates. It collected details of vocational education and training courses undertaken by students, as well as employer details and future study intentions. Main users of this survey were the Australian National Training Authority and TAFE colleges.

Scope

All 1994 TAFE graduates in all States and Territories who were Australian residents and were eligible for one of the following awards: Diploma; Associate Diploma; Advanced Certificate -Post Trade; Advanced Certificate — Other; Certificate — Trade; or Certificate - Other; whose course was at least 200 hours or one semester in duration.

Note: Since May 1993 the Transition from Education to Work Survey has collected level and main field study of post-school qualifications according to the Australian Bureau of Statistics Classification of Qualifications (ABSCQ). As a result of questionnaire rewording and the use of ABSCQ, short course certificate qualifications were excluded. Hence, the estimate of persons with post-school qualifications in February 1994 is 300,000 less than would be expected using the earlier classification of qualifications.

DESCRIPTION

The 1996 Training Expenditure Survey was a repeat of similar surveys previously conducted in the September quarters of 1989, 1990 and 1993. The survey provided national estimates of expenditure by employers on the structured training of their employees. It also provided estimates of the paid time employees spent receiving structured training. Structured training is defined as training activities which have a predetermined plan and format designed to develop work-related skills and competencies. Unstructured training was excluded from the survey because of the considerable difficulties associated with its measurement. However, structured on-the-job training was included in the survey. Statistics on the costs incurred by organisations in training employees were produced by industry; employer size; public and private sectors; and State.

The survey collected direct costs associated with training time. It excluded the replacement cost of employees on training courses and training undertaken outside normal working hours at no expense to the employer. Data for the survey were recorded on an actual expenditure basis. Annual fees (such as enrolment fees for educational institutions) were only included in the survey if they were paid in the reference period.

The 1997 Training Practices Survey was an enhancement of a similar survey conducted in 1994. Information was collected from employers in Australia on factors affecting the provision of training and how training is planned. The survey sought information on training practices as they applied to the organisation as a whole and not individual employees. Responses on reasons for training were gathered by employer size, by sector and by industry.

For 1994, specific questions also related to the impact of the Training Guarantee legislation, introduced in 1990, and how this legislation affected employer training practices. For the 1997 survey, additional information was collected on unstructured training.

The sample of employers for this survey was the same as that for the Training Expenditure Survey. Most estimates derived solely from the Training Practices Survey are expressed as a proportion of employers. However, data can be cross-classified with the Training Expenditure Survey, 1993, to obtain training expenditure expressed as a proportion of employers' gross wages and salaries.

#### DESCRIPTION

The Labour Force Survey is a monthly household survey providing a wide range of statistics about the Australian civilian labour force. In particular, it provides monthly employment and unemployment estimates. Labour Force Survey estimates are used to facilitate the analysis and monitoring of social and economic aspects of the Australian labour market and working age population, particularly by the Commonwealth Government and State Governments, to support the development, implementation and evaluation of labour market policies.

Associated with the monthly Labour Force Surveys are the Labour Force Supplementary Surveys which provide more detailed information about various aspects of the Australian labour market. The topic of the monthly supplementary survey varies from month to month.

## Scope

Covers persons of working age (15 years and over) who are civilians, usually resident in Australia. Excluded from the survey are members of the permanent defence forces, certain diplomatic personnel of overseas governments, overseas residents in Australia, and members of non-Australian defence forces (and their dependants) stationed in Australia.

## GEOGRAPHIC COVERAGE

## FREQUENCY OF COLLECTION

The data are collected and published monthly. The February, May, August and November surveys collect additional statistics, namely industry and occupation of employment, and status in employment.

#### METHOD OF COLLECTION

Estimates of the civilian labour force are derived from the Labour Force Survey part of the Monthly Population Survey. The population survey is based on a multi-stage area sample of private dwellings (about 30,000 houses, flats, etc.) and non-private dwellings (hotels, motels, etc.) and covers about one-half of 1% of the population of Australia. The information is obtained from the occupants of selected dwellings during a two-week period each month by carefully chosen and specially trained interviewers. In most months, additional questions are included for supplementary topics. As for all sample surveys, the estimates are subject to sampling error and non-sampling error.

Households selected for the Labour Force Survey are interviewed each month for eight months. The first interview is conducted face to face, with remaining interviews being conducted by telephone if acceptable to the respondent.

#### HISTORICAL DATA

The Population Survey was first conducted Australia-wide in February 1964. From November 1960 to November 1963 it was confined to a quarterly collection for the six State capital cities. Due to changes in the frequency of the survey, changes to questions and definitions and revisions to the population benchmarks, current estimates may not be strictly comparable with the early estimates. Estimates from August 1966 are published in *The Labour Force, Australia: Historical Summary, 1966 to 1984* (Cat. no. 6204.0). Since February 1978, the data have been collected every month, and only minor changes to the survey have been made, allowing a time series of monthly estimates from February 1978 onwards.

Note: Due to a number of changes in the classification systems used for occupation and industry coding since 1978, a time series from 1978 for these estimates is not available.

DESCRIPTION

The first National Aboriginal and Torres Strait Islander Survey, conducted throughout Australia during April to July 1994, obtained information about the social, economic and cultural status, conditions and attitudes of Australia's Indigenous population. The survey provides a strong information base for planning for Australia's Indigenous peoples, for meeting their objectives, aspirations and needs, and for measuring progress in meeting these.

Scope

The survey sample was selected from all the people identifying as Aboriginal or Torres Strait Islander living in Australia. Non-Indigenous people usually residing in households with Indigenous people were included so that the information for families and households would be complete. Solely non-Indigenous households were excluded from the survey. It included both private and special dwellings and where possible, people not living in dwellings (campers-out). Private dwellings include houses, flats, home units, garages, tents and improvised houses. Special dwellings are prisons, educational institutions, nursing homes, caravan parks, hostels, staff quarters, etc. The survey encompassed remote, rural and urban areas, and included all States and Territories.

A sample of approximately 5,000 dwellings throughout Australia, comprising about 6.6% of the Aboriginal and Torres Strait Islander population, was selected at random using a multistage sample design stratified by the 35 ATSIC Regions and Torres Strait area. This design ensured the sample was nationally representative of Aboriginal and Torres Strait Islander people living in all different circumstances across the country.

The survey data were collected from the selected Aboriginal and Torres Strait Islander people in personal interviews by trained Indigenous interviewers. The survey was extensively tested and used culturally appropriate methodology.

# HISTORICAL DATA

Apart from the ABS Census of Population and Housing, there are very little national, historical data available on Aboriginal and Torres Strait Islander people.

Note: Some attitudinal information may have been influenced by the circumstances of the interview itself and may reflect short-term views rather than usual feelings or circumstances. As a result, some caution should be used in interpreting these data as necessarily indicative of general or usual perceptions. When collecting the education and training statistics, the full details of courses attended may have been unavailable. In these cases, coding of qualifications was undertaken using the limited amount of information recorded. This is likely to have had some effect on the accuracy of level of qualifications, including a relatively large number of qualifications categorised as inadequately described.

The National Nutrition Survey was conducted in association with the 1995 Health Survey as a joint project between the ABS and the Commonwealth Department of Health and Family Services (DHFS).
