

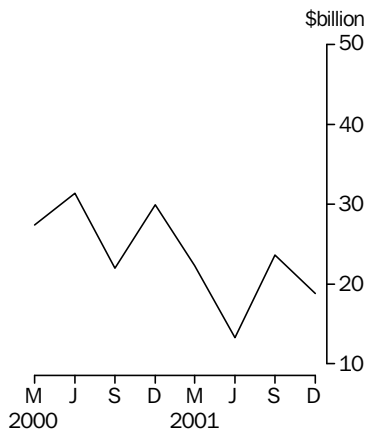

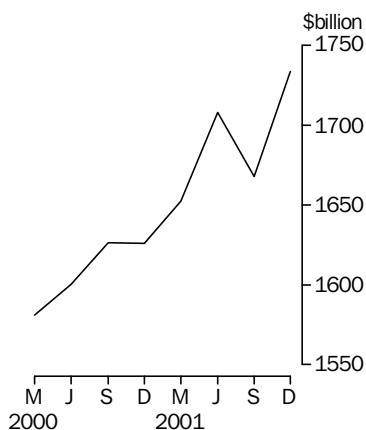

DECEMBER QTR KEY POINTS

SUMMARY

- Total demand for credit by the non-financial domestic sectors for the December quarter 2001 was \$18.8 billion, which brought total credit market outstandings to \$1733.8 billion after valuation increases of \$47.1. The valuation increases during December did not reverse completely the valuation losses of \$63.8 billion during the September quarter 2001. Demand by households was very strong at \$22.6 billion, with housing borrowing being the main component.

NON-FINANCIAL CORPORATIONS

- Private non-financial corporations repaid a net \$5.0 billion during the quarter. Share raisings of \$5.9 billion and bond issues of \$0.5 billion were offset by repayments of loans of \$9.6 billion and redemptions of short term debt securities totalling \$1.8 billion.
- Public non-financial corporations raised \$0.9 billion during the quarter.

GENERAL GOVERNMENT

- National general government raised a net \$0.6 billion during the quarter, mainly through issue of short term debt securities. State and local general government redeemed \$0.4 billion mainly through repayment of loans.

HOUSEHOLDS

- Households raised a net \$22.6 billion during the quarter to bring their total outstandings to \$548.2 billion at the end of December 2001. Borrowing for housing was strong with \$12.5 billion borrowed from banks and \$4.9 billion from securitisation vehicles.

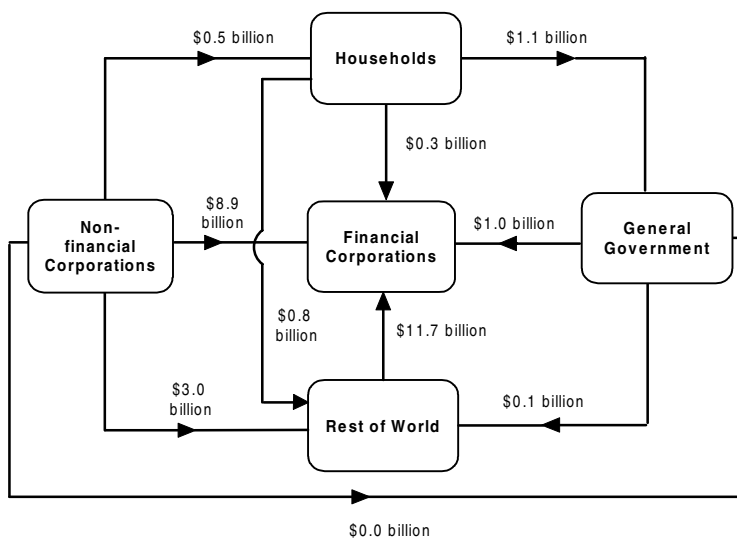

INTERSECTORAL FINANCIAL FLOWS AND CLAIMS

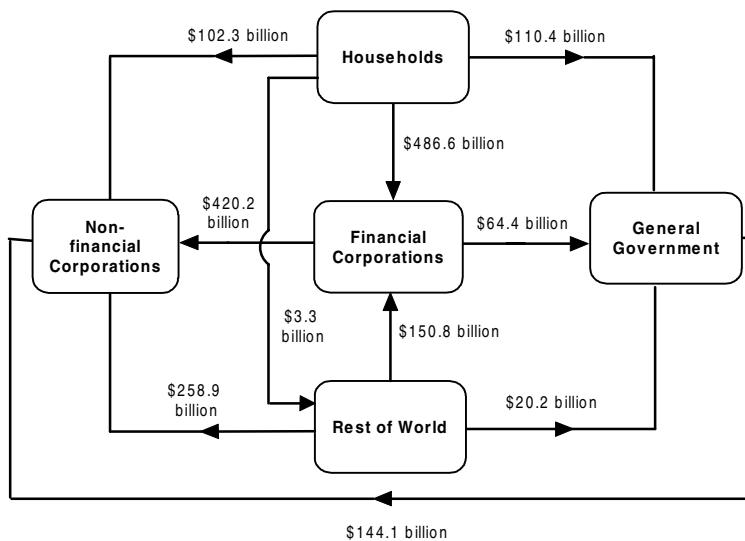
FLAWS DURING DECEMBER QUARTER 2001

During the December quarter 2001 non-financial corporations repaid a net \$8.9 billion to financial corporations and \$3.0 billion to rest of world. Financial corporations borrowed a net \$11.7 billion from rest of world.



CLAIMS AT END OF DECEMBER QUARTER 2001

At the end of December 2001, claims on non-financial corporations stood at \$102.3 billion from households, \$144.1 billion from general government, \$258.9 billion from rest of world and \$420.2 billion from financial corporations. Financial corporations also had claims on general government of \$64.4 billion. Financial corporations financed claims on other sectors from net claims by rest of world, \$150.8 billion, and by households, \$486.6 billion.

FINANCIAL MARKET ANALYSIS

During the December quarter 2001 financial market valuations increased by a net \$112 billion, recovering much of the \$122.4 billion lost during the September quarter 2001.

Deposit liabilities increased to \$631.9 billion at 31 December 2001, following net transactions of \$29.2 billion during the December quarter 2001, compared to transactions of \$15.1 billion in the previous quarter. Of these net transactions, \$24.7 billion was in bank deposits, up \$14.4 billion on September 2001 quarter results.

Short term security liabilities decreased to \$295.0 billion at 31 December 2001, with net issuance of \$0.1 billion offset by a valuation decrease of \$2.3 billion during the quarter. \$5.3 billion was issued on the Australian market, with a net redemption of \$4.6 billion offshore. There was a net decrease in bills of exchange on issue of \$0.6 billion.

Net issues of bonds was \$7.2 billion during the December quarter. Banks issued \$1.8 billion, of which \$1.4 billion was issued offshore, while national general government redeemed a net \$0.3 billion all in Australia. Financial intermediaries n.e.c. issued a net \$5.2 billion of which \$5.5 billion was issued in Australia.

The value of derivative contracts on issue at 31 December 2001 decreased by \$20.5 billion to \$88.2 billion following net settlements of \$12.8 billion.

Loan liabilities rose to \$1265.4 billion at 31 December 2001 following net transactions of \$17.3 billion during the quarter.

The listed share market increased by \$84.6 billion to \$767.4 billion at 31 December 2001. There was a net \$4.1 billion issue of shares and valuation changes of \$80.5 billion.

The value of the unlisted share market increased by \$54.0 billion to \$722.9 billion at 31 December 2001. There were net issues of \$17.6 billion mainly due to an increase in Australian investment overseas (\$7.1 billion), issues by financial intermediaries (\$4.6 billion) and private non-financial trading corporations (\$3.8 billion). Valuation increases amounted to \$36.4 billion.

At 31 December 2001 the reserves of life offices and pension funds were \$529 billion following net transactions during the quarter of \$5.2 billion and a valuation increase of \$21.6 billion. General insurance prepayments and reserves were \$54.3 billion.

SECTORAL ANALYSIS

NON-FINANCIAL CORPORATIONS

SUMMARY

Private non-financial corporations reduced borrowings by a net \$10.9 billion (excluding derivatives and accounts payable) in the December quarter 2001. They paid off \$9.6 billion in loans and withdrew a net \$1.3 billion in debt securities. New share issues raised a net \$5.9 billion during the quarter. These transactions reduced total borrowings outstanding to \$390.5 billion and raised total equity on issue to \$589.6 billion.

PRIVATE NON-FINANCIAL CORPORATIONS,
NET ISSUE OF EQUITY AND BORROWINGS



During the December quarter 2001 total liabilities of national public non-financial corporations increased by \$2.6 billion to \$106.8 billion. Net issue of debt securities was \$0.6 billion and net loan borrowing was \$0.1 billion. Accounts payable were reduced by \$0.2 billion. Liabilities of state and local public non-financial corporations decreased by \$1.7 billion to \$139.1 billion. Devaluation of unlisted shares on issue of \$1.9 billion contributed to this decrease. Drawings of Bills increased by \$0.2 billion for the quarter. A withdrawal of \$0.6 billion in unlisted shares and other equity has been disclosed for the September quarter 2001. This transaction represents the privatisation of assets by the Ports Corporation of Queensland and the subsequent decrease in equity held by the Queensland Government in that agency.

PRIVATE NON-FINANCIAL CORPORATIONS DEBT TO EQUITY RATIO

From March quarter 2000 to December quarter 2001 debt outstanding rose by \$49.4 billion, whilst the value of equity on issue increased by \$24.1 billion. During the December quarter debt decreased by \$15.9 billion and equities on issue increased by \$54.3 billion. In original terms the debt to equity ratio dropped to just under the June 2001 quarter ratio. In adjusted terms the debt to equity ratio fell to the lowest level recorded since September 1997. The adjusted ratio reflects the removal of price change from the original series.

FINANCIAL CORPORATIONS

SUMMARY

During the December quarter 2001, Financial corporations issued \$40.6 billion liabilities on a consolidated basis. The Central bank (\$10.9 billion), Banks (\$27.4 billion), Financial intermediaries nec (\$10.6 billion), Pension funds (\$2.9 billion) and Life insurance corporations (\$1.2 billion) were net issuers of liabilities. The groups of financial corporations that significantly withdrew, repaid or redeemed liabilities were State central borrowing authorities (\$4.9 billion) and Other depository corporations (\$2.1 billion).

BANKS

During the quarter, banks increased their deposit liabilities (\$29.6 billion), equity issuance (\$1.6 billion) and bonds issuance (\$1.8 billion). There were also significant redemptions of bills of exchange (\$3.5 billion) and settlements of derivatives (\$4.0 billion) by banks.

Banks acquired financial assets of \$6.6 billion during the quarter. There was a net acquisition of loans and placements (\$11.9 billion), with a notable increase in loans to households (\$14.4 billion) and decrease in loans to private non-financial corporations (\$3.3 billion). Banks also increased their holdings of equity (\$3.2 billion). In contrast, banks reduced their holdings of other assets such as derivatives (\$5.7 billion), bonds (\$0.7 billion) and bills of exchange (\$0.6 billion).

OTHER DEPOSITORY CORPORATIONS

Funding of other depository corporations decreased by \$2.1 billion during the December quarter 2001 following decreases in deposit liabilities of \$1.6 billion, derivatives of \$2.3 billion, and loan liabilities of \$0.2 billion. These were partially offset by issuance of shares (\$1.7 billion), debt securities (\$0.2 billion) and accounts payable (\$0.2 billion).

Financial assets decreased by \$2.2 billion with decreases in derivatives (\$2.3 billion), and loans (\$1.5 billion) being the main contributors. Of note was the switch in the loan asset portfolio with loans to private non-financial trading corporations decreasing by \$4.4 billion and loans to households increasing by \$2.9 billion.

LIFE INSURANCE CORPORATIONS

At the end of the December quarter 2001 the non-pension fund net equity in reserves of life insurance corporations was \$47.4 billion, following transactions of \$1.9 billion during the quarter. Pension funds increased their holdings of reserves in life insurance corporations by \$0.6 billion to \$122.1 billion. During the December quarter 2001, transactions in life insurance corporations' liabilities were \$1.2 billion, financial asset acquisition was \$1.1 billion leading to an overall net decrease in financial position of \$0.1 billion.

PENSION FUNDS

Net equity in reserves of pension funds was \$481.6 billion at the end of the December quarter 2001, following net transactions of \$3.3 billion during the quarter. Transactions in financial assets were \$2.0 billion, due mainly to acquisitions of short-term debt securities (\$2.3 billion), currency and deposits (\$1.3 billion), loans and placements (\$1.0 billion) and bonds (\$0.5 billion). These were offset by net sales of equities (\$3.6 billion).

FINANCIAL CORPORATIONS *continued*

OTHER INSURANCE CORPORATIONS

Total transactions in financial assets were \$1.4 billion which brought total financial assets to \$81.8 billion following acquisitions of equities held (\$1.4 billion), loans and placements (\$0.4 billion), and bonds (\$0.6 billion). These were offset by a reduction in accounts receivable (\$0.6 billion) and sales of short-term debt securities of (\$0.5 billion).

Reductions in liabilities totalled \$0.5 billion following a net decrease in prepayments of premiums and reserves (\$0.3 billion) and other accounts payable (\$0.3 billion).

CENTRAL BORROWING AUTHORITIES

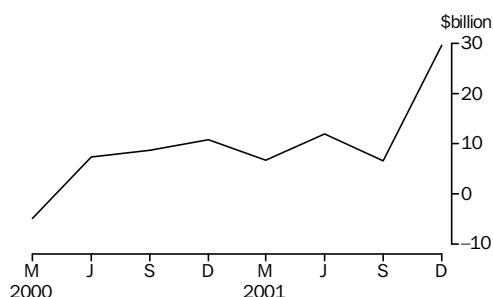
Total liabilities of central borrowing authorities decreased by \$4.9 billion to \$87.2 billion at the end of the December quarter. There were net redemptions in bonds (\$1.2 billion), one name paper (\$1.8 billion) and loans (\$1.1 billion).

FINANCIAL INTERMEDIARIES N.E.C.

Financial intermediaries n.e.c. increased funding by \$10.6 billion in the December quarter 2001. The major contributors were issues of unlisted shares and other equity (\$4.8 billion), net issuance of bonds (\$3.4 billion) and loans and placements (\$1.8 billion). Transactions in financial assets were \$10.0 billion following an increase in loans and placements (\$6.7 billion), shares and other equity (\$4.0 billion) and currency and deposits (\$1.7 billion), which were offset somewhat by net sales of bills of exchange (\$1.3 billion) and bonds (\$2.0 billion).

NET FLOW OF CURRENCY AND DEPOSITS TO BANKS

The net transaction in currency and deposit liability with banks during the December quarter 2001 was \$29.6 billion. The largest contributions were made by households, \$12.8 billion, rest of world \$10.5 billion, and private sector trading corporations \$5.6 billion. Some of the large increase in currency and deposits by households reflects deposits of borrowed funds not yet used for their intended purpose.

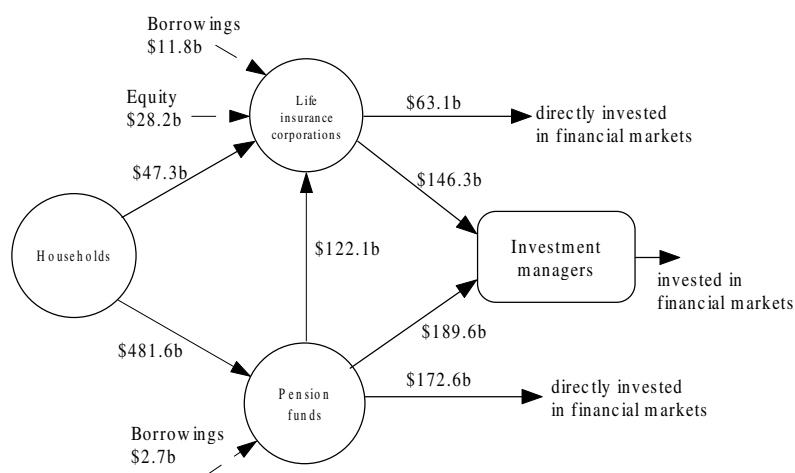
ASSET PORTFOLIO OF LIFE INSURANCE CORPORATIONS AND PENSION FUNDS AT END OF QUARTER

At the end of December quarter 2001 life insurance corporations held \$116.4 billion in shares and other equity (59% of their financial assets), of which \$87.9 billion was in resident companies and \$28.5 billion was in non-resident companies; \$39.1 billion in bonds (20% of their financial assets), of which \$32.9 billion was in Australian bonds and \$6.2 billion in non-resident bonds; and \$15.1 billion in short term securities (8% of their financial assets).

At the end of the December quarter 2001 pension funds held \$228.8 billion in shares and other equity (49% of their financial assets), of which \$168.2 billion was in resident companies and \$60.5 billion was in non-resident companies. They held \$122.1 billion of net equity in life office reserves (26% of their financial assets); and \$37.4 billion in bonds (8% of their financial assets), of which \$28.0 billion were Australian bonds and \$9.5 billion were non-resident bonds.

FINANCIAL CLAIMS BETWEEN HOUSEHOLDS, LIFE INSURANCE COMPANIES, PENSION FUNDS AND INVESTMENT MANAGERS AT END OF QUARTER

At the end of the December quarter 2001 households had claims against the reserves of life insurance corporations of \$47.4 billion and pension funds of \$481.6 billion. Pension funds had claims against the reserves of life insurance corporations of \$122.1 billion. Life insurance corporations invested \$146.3 billion of their financial assets through investment managers and pension fund invested \$189.6 billion through investment managers.

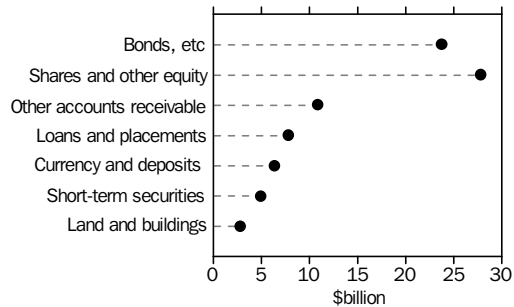

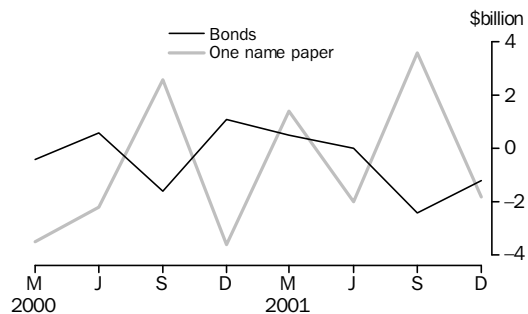
ASSET PORTFOLIO OF OTHER INSURANCE CORPORATIONS AT END OF QUARTER

The graph below shows that at the end of December quarter 2001 other insurance corporations held \$23.7 billion in bonds (29% of total financial assets), of which \$20.5 billion were Australian bonds and \$3.2 billion were non-resident bonds; and \$27.8 billion in shares and other equity (34% of total financial assets), of which \$24.6 billion was in resident corporations and \$3.2 billion in non-resident corporations.



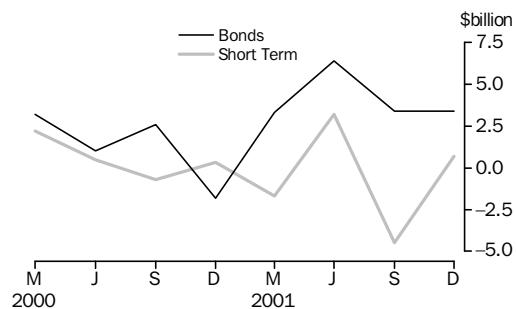
CENTRAL BORROWING AUTHORITIES NET ISSUE OF DEBT SECURITIES

Central borrowing authorities had net redemptions in one name paper of \$1.8 billion and bonds of \$1.2 billion in the December 2001 quarter.



FINANCIAL INTERMEDIARIES N.E.C. NET ISSUE OF DEBT SECURITIES

During the December quarter 2001 financial intermediaries n.e.c. made net issuances in short term securities of \$0.7 billion and bonds of \$3.4 billion (mainly asset backed securities).

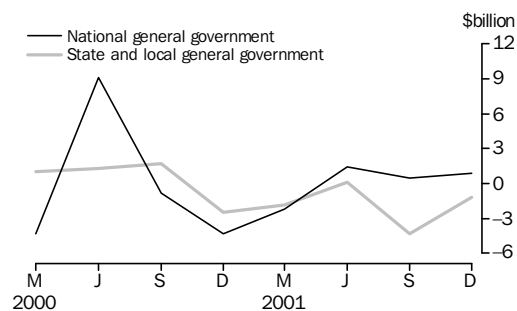
GENERAL GOVERNMENT

SUMMARY

During the December quarter 2001, general government transactions resulted in a net change in financial position of -\$0.3 billion, see Table 33H. National general government increased its liabilities by \$1.2 billion and increased its financial assets by \$2.1 billion to record a net change in financial position of \$0.9 billion, see Table 29 and the graph below. Assets increased mostly due to a \$1.3 billion increase in currency and deposits and a \$0.7 billion increase in other accounts receivable, offset by a reduction in derivatives of \$0.2 billion. The increase in liabilities was mainly due to the net domestic issue of one name paper (\$0.5 billion) and unfunded superannuation claims (\$0.5 billion). At the end of December 2001, national general government had total liabilities of \$175.7 billion and total financial assets of \$108.0 billion.

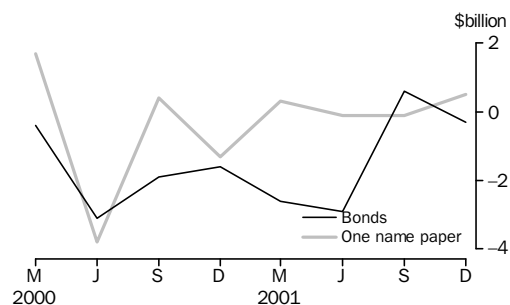
State and local general government financial assets decreased by \$0.3 billion in the December quarter 2001. Total liabilities increased by \$0.9 billion, resulting in a net change in financial position of -\$1.2 billion. At the end of the quarter, State and local general government had total liabilities of \$87.4 billion and total financial assets of \$119.3 billion.

CHANGE IN FINANCIAL POSITION



NATIONAL GOVERNMENT NET ISSUE OF DEBT SECURITIES

The accompanying graph illustrates the national general government's bond issuance, with a net decrease of \$0.3 billion in treasury bonds during the quarter. Short term debt security liabilities had a net increase of \$0.5 billion over the quarter.

HOUSEHOLDS

SUMMARY

Households borrowed \$22.5 billion in the form of loans during the December quarter 2001, with borrowing for housing being the main influence. Some of this increased borrowing remained in deposit asset accounts which increased by \$16.2 billion.

Households purchased a net \$1.7 billion in equities during the December quarter 2001. Purchases of \$0.9 billion in financial intermediaries n.e.c. shares and purchases of \$0.8 billion in foreign equities were offset by sales of \$0.7 billion in private non-financial corporations shares.

At the close of the quarter households' stock of financial assets was \$1267.7 billion. Net equity in reserves of life insurance corporations and pension funds accounted for 42% of this total, currency and deposits 24%, equities issued by domestic sectors 19 % and unfunded superannuation claims 9 %.

HOUSEHOLD NET BORROWING

During the December quarter 2001 households borrowed a net \$23.7 billion, of which \$14.4 billion was in the form of bank loans. This borrowing raised household bank loan liabilities to \$390.7 billion for the December quarter 2001.

INSURANCE AND PENSION CLAIMS

During the December quarter 2001 households' net equity in reserves of pension funds increased by \$22.3 billion, of which \$3.3 billion was an increase in net transactions and \$19.0 billion valuation increases, bringing the household net equity in pension funds to \$481.6 billion.

Net equity in reserves of life insurance corporations increased by \$4.5 billion, to \$47.4 billion.

Household claims against unfunded superannuation increased by \$1.6 billion during the quarter. Prepayments of premiums and claims against reserves in general insurance corporations decreased by \$0.1 billion.

REST OF THE WORLD

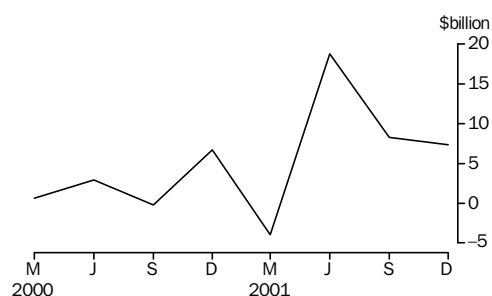
SUMMARY

Non-residents invested a net \$9.5 billion in Australian financial assets during the December quarter 2001. The largest net increases were in their holdings of currency and deposits, \$10.3 billion, followed by purchases of equities, \$7.4 billion (of which \$6.3 billion were issued by private non-financial corporations) and purchases of bonds, \$3.3 billion. These were offset by non-residents reducing their holdings of one name paper by \$4.5 billion, and derivative contracts by \$3.6 billion. Overall, the value of Australian financial assets held by non-residents increased to \$853.7 billion at the end of the quarter.

Australian residents purchased foreign financial assets worth \$3.6 billion during the December quarter 2001. The major transactions during the quarter were purchases of equity, \$7.1 billion, these were partly offset by decreases in the holdings of derivative contracts by \$3.6 billion. Overall, the total value of foreign assets held by Australian residents increased to \$441.1 billion at the end of the quarter.

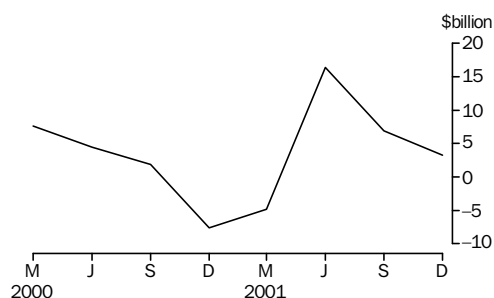
NET PURCHASES OF EQUITIES

The accompanying graph shows that during the December quarter 2001 non-residents purchased a net \$7.4 billion in equities, a decrease of \$0.9 billion compared with the September quarter 2001.



NET PURCHASES OF BONDS

The accompanying graph shows that non-residents purchased \$3.3 billion of Australian bonds during the December quarter 2001, a decrease of \$3.6 billion compared with the September quarter 2001.

EXPLANATORY NOTES

INTRODUCTION

1 This publication contains financial profiles of each subsector of the economy and the market for each conventional financial instrument. There are also tables showing inter-sectoral financial transactions and measures of sectoral financial surpluses and deficits.

2 Financial accounts of various types—which are also called flow of funds statistics—are published by many OECD countries, including the United States (from 1945), the United Kingdom (from 1952) and Canada (from 1962). In Australia, the Reserve Bank produced annual flow of funds accounts for the reference years 1953–54 to 1988–89. The final edition of these was published in the Reserve Bank's *Bulletin* for November 1989. The Australian Bureau of Statistics (ABS) has published quarterly estimates commencing with experimental estimates of inter-sectoral financial transactions for the March and June quarters 1989.

CONCEPTS, SOURCES AND METHODS

3 From the September quarter 1998 the ABS financial accounts have been produced according to a revised international standard, the *System of National Accounts*, released in 1993 (SNA93) under the auspices of five international organisations: Commission of the European Communities—Eurostat, International Monetary Fund, Organisation for Economic Co-operation and Development, United Nations, and World Bank. There are significant conceptual differences between the SNA93-based ABS Financial Accounts and the previous Financial Accounts (see ABS Information Paper Cat. no. 5254.0).

4 The ABS has released an updated version of *Australian National Accounts: Concepts, Sources and Methods* (Cat. no. 5216.0), which provides detailed descriptions of the concepts, data sources and methodologies used in compiling the Australian national accounts, including the financial accounts, on an SNA93 basis. The document was released in December 2000. Selected concepts, sources and methods are outlined below. More detailed explanations can be obtained from the contact on the front cover of this publication.

STOCK AND FLOW CONCEPTS

5 Tables 1 to 16 and 34 to 41 present balance sheet data at market prices at the end of each calendar quarter. Balance sheet data are also known as stock, level or position data. In contrast Tables 17 to 33 show net inter-sectoral financial transactions during the quarters. These are flow data. In this publication, the net transactions or flows, are defined as active dealing in a financial instrument.

THE CLASSIFICATION OF INSTITUTIONAL SECTORS AND SUBSECTORS

6 The institutional sectors are based on the *Standard Economic Sector Classifications of Australia 1998* (Cat. no. 1218.0) and are the same as the sectors used in national income and expenditure accounts.

7 The basic unit that is classified by sector is the institutional unit, which is defined as an economic entity that is capable, in its own right, of owning assets, incurring liabilities and engaging in economic activities and transactions with other entities.

EXPLANATORY NOTES *continued*

SOURCES OF DATA

8 Most of the financial data in this publication are derived from statistical surveys conducted by the ABS. Some other data sources are used, particularly for valuation adjustments.

9 The quarterly sectoral capital accounts in the flow of funds matrices are prepared using a variety of indicators to dissect annual estimates based on survey data. Some of the indicators used are known to be of poor quality, these are footnoted in tables to note the quality concerns and should be used with caution.

COMPILATION METHODS

10 The levels (stock) tables are prepared by gathering together balance sheet information from various sources and selecting the better estimates. A choice is often possible because different data sources provide alternative or *counterpart* measures of the same item. For example, borrowing by State owned non-financial corporations will be reported by the State central borrowing authorities or Treasuries as assets and by the non-financial corporations as liabilities. The sub-sector aggregates derived from these data do not agree because the ABS does not survey all State owned non-financial corporations. In this case, the data from the central borrowing authorities and Treasuries are therefore used to estimate both the asset and liability aspects of these borrowings.

11 In some cases, transactions data are directly-collected. In other cases transactions must be derived from the difference in consecutive levels. These net financial transactions are derived by taking the difference between closing and opening levels of balance sheet items and, where possible, eliminating changes on the balance sheet caused by valuation effects such as exchange rate movements.

ACCOUNTING BASIS

12 SNA93 states explicitly that the national accounts should record transactions on an accrual basis (as opposed to a cash or 'due for payment' basis), to reflect the time when economic value is transferred rather than when cash relating to the transaction is paid or falls due for payment. For practical reasons complete implementation of accrual accounting throughout the national accounts is not yet possible. Some areas where accrual accounting has not been adopted include:

- accrual of household income tax; and
- accrual of certain employee entitlements, including recreation and long service leave.

13 In these statistics tradeable securities, which include shares listed on ASX and debt securities traded on organised markets, are valued at market prices.

14 Other securities are assigned estimated market values. For example, equity not listed on ASX is valued on the basis of value of total assets of the enterprise in question less the value of any repayable liabilities.

15 Deposits, loans and other accounts payable/receivable are recorded at their face value.

16 Net equity of pension funds in life office reserves are valued on the basis of market value of total assets (including non financial assets) of the funds less any repayable liabilities.
