ANALYSIS OF TABLE 1.1

The estimated resident population of Western Australia at 30 June 1997 was 1,798,100, an increase of 7,700 in the June quarter and 32,800 in the financial year 1996-97. The annual growth rate during 1996-97 was 1.86% compared with a rate of 1.82% in the previous year.



ANALYSIS OF TABLE 1.2

In the June quarter 1997, the population increased by 7,700 compared with an increase of 8,500 in the previous quarter. Both the natural increase and net estimated overseas migration were lower than the March quarter 1997. However, net estimated interstate migration increased to 2,100 from zero in the previous quarter.

For the financial year 1996-97 the increase of 32,900 was 8.2% higher than the increase in the previous year.

ANALYSIS OF TABLE 1.3

The number of marriages in the June quarter 1997 fell by 342 or 11.8% on the previous quarter. The total of 2,562 marriages in June quarter 1997 was a rise of 4.6% on June quarter 1996.

The total number of deaths increased by 77 from March quarter 1997, a rise of 3.3%. The number of live births fell by 0.4% and divorces fell by 8.1% from March quarter 1997. Compared to June quarter 1996, the number of deaths decreased by 213 or 8.1% and births decreased by 20 or 0.3%. The number of divorces fell by 30, or 2.6%.

Preliminary data for 1996-97 shows a drop of 41 live births or 0.2% from the previous year. The number of divorces fell by 264 or 5.1% and marriages rose by 353 (3.5%). Total deaths fell by 109 or 1.0% and infant deaths decreased by 10 or 7.1%.

ANALYSIS OF TABLE 1.4

The rate of infant deaths continued to fall, from 4.8 infant deaths per 1,000 live births in the March quarter 1997 to 4.3 infant deaths in the June quarter 1997.

Compared to June quarter 1996, rates declined by 0.3 for live births, 0.6 for total deaths, 0.3 for infant deaths and 0.1 for divorces. The rate of marriages increased by 0.1.

The rates for live births, infant deaths, marriages and divorces in June quarter 1997 all decreased on the previous quarter. Only the rate for deaths increased, by 0.2.

Compared to 1995-96, preliminary rates for 1996-97 show falls for live births, infant deaths, total deaths and divorces, but a rise for marriages.

ANALYSIS OF TABLE 2.1

Total arrivals in November 1997 were 18% lower than in the previous month and were 6% higher than in November 1996.

The number of Western Australian residents returning from short-term visits overseas fell by 35% from the previous month to 28,170 persons. This was a 12% increase over November 1996. The number of overseas visitors arriving in Western Australia for short-term visits increased by less than 1% from October 1997 and by 2% since November 1996.

The number of residents returning to Western Australia in November 1997 after a long-term stay overseas, increased by 24% on the previous month and decreased by 4% on the November 1996 level. Arrivals of long-term overseas visitors decreased by 28% on October 1997, and increased by 29% on November 1996 figures.

Total departures in November 1997 rose by 5% on the previous month and were 14% higher than in November 1996.

The number of short-term departures of Western Australian residents fell by 8% on October 1997, and rose by 14% on November 1996 figures. Short-term departures of overseas visitors rose by 17% on October 1997. The number of long-term departures of overseas visitors rose by 82% on October 1997 and long-term departures of Western Australian residents rose by 9% over the same period.

ANALYSIS OF TABLE 2.2

Total short-term overseas visitor arrivals rose by less than 1% on October 1997. The total of 37,840 arrivals in November 1997 was 2% higher than in November 1996.

The number of visitors from the United Kingdom and Ireland in November 1997 increased by 600 or 7% on October 1997 and decreased by 5% on November 1996. Short-term arrivals from Indonesia decreased by 19% on October 1997, and decreased by 14% on November 1996.

ANALYSIS OF TABLE 2.3

The number of short-term overseas visitor arrivals for holidays in Western Australia in November 1997 rose by 4% on October 1997. There was a total of 20,080 visitors in November 1997 compared with 20,580 in November 1996.

For November 1997, there was an increase in the number of holidaymakers from Singapore of 1,080 or 26%, compared with October 1997. Holidaymakers from the United States of America increased by 280 or 156%. The number of holidaymakers from Malaysia decreased by 910 or 29% and by 210 persons or 57% from Thailand.

Compared with November 1996, the number of holidaymakers from New Zealand increased by 92% and by 29% from Japan. Over the same period the number of holidaymakers from Singapore decreased by 19% and by 17% from Indonesia.



ANALYSIS OF TABLE 2.4

For November 1997, short term departures of residents from Western Australia decreased by 2,470 persons, or 8%, on October 1997. The total of 28,280 persons was 3,430 or 14% higher than recorded for November 1996. Compared with October 1997, short-term departures of residents to Malaysia and Singapore increased by 12% and 18% respectively. The number of short-term departures of residents to New Zealand fell by 21% and to Indonesia by 25%.

ANALYSIS OF TABLE 2.5

There were 14,380 short-term departures of Western Australian residents for holidays abroad in November 1997. This was 5,030 residents or 26% less than departed in October 1997 and 1,760 residents more than in November 1996.

For November 1997, the only country listed which recorded an increase in the number of Western Australian short-term holidaymakers was Malaysia. Of the other popular holiday destinations for Western Australians, the United Kingdom and Ireland, Indonesia, Singapore, Thailand, New Zealand and the United States of America recorded decreases in the number of holidaymakers visiting since October 1997.

Indonesia continues to be the favoured short-term holiday destination for Western Australian residents. Of the total of 14,380 departures for November 1997, 6,270 or 44% chose Indonesia as their holiday destination.

Compared with November 1996, departures of holidaymakers increased by 14% overall. Malaysia recorded a decrease of 8%. Thailand and New Zealand recorded increases, by 144% and 52% respectively, in the number of short term visitors from Western Australia.








